- FOR USE IN AUTO SCRUBBERS: Add 1 ounce of concentrate per gallon of water in the reservoir tank.
- 2. Apply solution to surface. For general cleaning, brush or sponge onto surface. For Wet mopping, apply freely to the floor with a mop or sponge.
- 3. Rinse with clean water using a sponge, cloth, or mop.

These directions are flexible rather than specific. In many cases a more dilute solution can be used, while for extreme conditions a less dilute solution may be used.

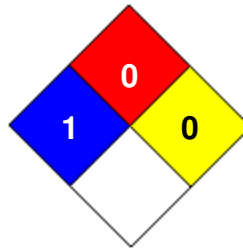
