DESCRIPTION

An all-purpose neutral cleaner/maintainer with superior cleaning power for use on any surface not effected by water. Ideal for use on sealed wood floors for cleaning and buffing finishes to a brilliant shine. Provides excellent emulsifying and penetrating action in both hot and cold water. Cleans, polishes, and preserves. Ideal for use with buffing programs. May be used for damp mopping, auto scrubbing or heavy duty cleaning.

DIRECTIONS

FOR DAMP MOPPING: Add 4 ounces of concentrate per gallon of water. Damp mop floors and allow to dry. Buff thoroughly with a polishing pad. For damp mopping without buffing, use 2 ounces per gallon of water.

FOR USE WITH AUTOMATIC SCRUBBERS: Add 4 ounces of concentrate per gallon of water to supply tank of automatic scrubber. Scrub floors in the usual manner and allow to dry. Buff with a polishing pad. Use 2 ounces per gallon of water if buffing is not required.

FOR HEAVY DUTY CLEANING: Add 8 ounces concentrate per gallon of water. Apply to surface, scrub, and rinse in the usual manner.

FOR USE ON WOOD FLOORS as a cleaner/maintainer: Add 4 ounces of concentrate per gallon of water. Damp mop floors, being careful not to overwet or puddle material, and allow to dry. Buff thoroughly with a polishing pad. For damp mopping without buffing, use 2 ounces per gallon of water.

4. FIRST AID MEASURES

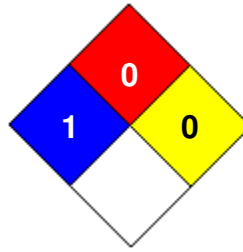
