It is ideal for cleaning concrete, ceramic tile, quarry tile, grout and brick and rubber mats with floor machine or mopping. For Grease, Oil and Other Heavy Duty Floor Cleaning: Diluted 6 to 8 ounce of product per gallon of water. Rinse thoroughly with clean water.

Apply product by spray, mop, sponge or auto-scrubber to surfaces to be cleaned. If necessary, agitate to help remove excessive soils. Rinse thoroughly with clean water as needed.

4. FIRST AID MEASURES

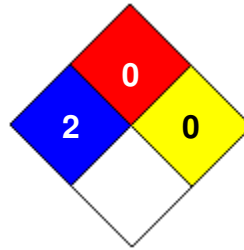
